PUBLIC ECONOMICS AND PUBLIC MANAGMENT

A DIVERSIFIED CENTER OF EXPERTISE

The modernisation promoted for over a decade by the head of state, H.E Paul Biya, President of the Republic of Cameroon. This notably involves:

- 1- University reforms instituted by the framework act 2001 bringing out the need of professionalism in Higher Education.
- 2. Financial reforms laid down in the 2007 State finance law and warranting new professional guidelines of implementation. This convergence of additional needs led to the signing of a convention agreement creating the Higher Institute of specialisation in Public Finances of cameroon by the Minister of Finance, the Minister of Higher Education and the Rector of university of yaounde II on 09 October 2013, first phase of which(the PSSFP) is operational in the Faculty of Economics and Managment of the University of Yaounde Il-Son.

The government, via human resources capacity building and emprowerment tools has created a center of excellence for the training of senior staff who will see to the implementation of the 2013 budget and accountancy reforms.

The professional masters in Public Finances is meant for those having a university diploma equal to a GCE "A" level + 3 and having acquired basic training in economics, managment and law or any other equivalent diploma. The Validation of Acquisition of Experience (VAE) can prevail based on the coherence between the training and professional project; in this case, a professional experience of at least five years (05) is needed.

07 YEARS LATER

07 years subsequent to its creation, the PSSFP graduated its third batch of 95 experts in public finances. These laureates are being recruited in the many national and international institutions and in the public administration.

With regards to development stakes which are increasingly demanding and the needs of the user administration, a new training offer was elaborated under the guidance of the FSEG of UYII. It comprises the following five courses: PUBLIC ECONOMICS AND PUBLIC FINANCES. TERRITORIAL GOVERNANCE AND LOCAL PUBLIC FINANCES: AUDIT AND CONTROL: PUBLIC CONTRACTS AND PUBLIC-PRIVATE PARTNERSHIP; TAXATION, FINANCE AND PUBLIC ACCOUNTANCY.
