- A SOLEMN UNDERTAKING TO RESPECT THE RULES OF THE TRAINING CENTRE;
- A MEDICAL CERTIFICATE DATED LESS THAN 03 MONTHS;
- 10 000 XAF FOR APPLICATION FEES.
