The State of Cameroon has issued on the CEMAC financial market, a bond called 'ECMR 2023 with multiple tranches of a volume of fcfa 150 billion'.

At the end of this operation, the result of subscriptions is FCFA 176,692,640,000, representing a subscription rate of 117.8% distributed as follows:
